Non-price vertical restraints include exclusive dealing and exclusive distribution agreements, and both are assessed under the rule of reason. (20) In exclusive dealing cases, a manufacturer arranges for a retailer (or customer at some other level) to carry only the manufacturer's line of products, and not the products of a competitor.

Analysing vertical agreements under competition law Commercial agreements concluded between companies operating at different levels of production or distribution chains (known as vertical agreements) need to be checked to ensure that any restraints do not breach competition law.
